Lanham asked to see the report when it is complete and will have the information available in the January board packet along with contractor quotes acquired by the Village. No action taken.

The board discussed the new requirements as of January 1, 2024 for employees - Paid Leave Act for All Workers. Currently the Village offers 48 hours of sick time for full time employees. In order to be in compliance with the new laws Pratt, seconded by Adams, made a motion to approve changing sick time to Paid Time Off and continue receiving 48 hours per year accrued per pay period and add paid time off for part time employees up to 40 hours per year to be accrued per pay period. This takes effect January 1, 2024 and keeps the Village in compliance with new state laws.
