Phase 3-Lighting/electrical upgrade and Phase 4-Chiller for rink to follow as the donations allow financially. The Goal is \$50,000 and is currently at donations received in the amount of \$5,750 towards Phase 2. The WPark team also requested the Village Trustees establish their support of all phases of the project as well as any future maintenance once the project is complete.
